Certified/Master Arborist. The Tree Risk Assessment Workshop was a success even though the attendance was less than expected.

Municipal Specialist. Planning the Urban Forest seminar will be held in June in Waco. Marcus Smith will chair a committee to look at By-Laws for life membership.
