- Bingo Parlors

- Elective or cosmetic surgery
- Event Centers
- Flea Markets
- Flower Shops (closed to retail but may deliver)
- Garage Sales
- Gyms and Fitness Centers
- Hair Salons
- Hobby Stores
- Malls (if there is outdoor access to retail stores and if they can provide pick-up in store/curbside conditions those businesses can continue)
- Medical Spa Facilities (can only operate if their services can meet the requirements set by the Governor regarding non-essential medical procedures)

- Restaurant Dine-in
- Retail Stores (unless providing delivery, pick-up, household necessities, food, etc.)
